3. The exhibition, use or discharge of the pyrotechnics (fireworks) shall be subject to such safeguards as may be prescribed by the City Fire Marshal.
4. The exhibition, use or discharge shall be subject to compliance with all applicable laws.

This permit is not transferable and only issued to the holder at the location and on the date set forth above for use in connection with the conduct of a public exhibition.
