5'3" - 5'4", 25 YOA, SLENDER BUILD, 120 LBS., MEDIUM COMPLEXION, BLACK HAIR, BROWN EYES, VERY THIN MUSTACHE AND THIN BEARD. VERY HOLLOW CHEEKS AND HIGH CHEEK BONES, SILVER RING ON LEFT RING FINGER.

BLACK MALE, 5'3", 19 YOA, VERY THIN, WEARING FADED DIRTY JEANS, BLACK LEATHER OR VINYL JACKET, WHITE SWEATSHIRT, DARK COMPLEXION.

GUN AND KNIFE

BLACK MALE, 5'7" - 5'9", 125 - 130 LBS., 25-30 YOA, BURGANDY JACKET WITH HOOD PULLED UP OVER A GRAY SWEATSHIRT WIT HOOD PULLED UP, BLUE JEANS. GRAY GLOVES, NO FACIAL HAIR DARK BROWN COMPLEXION.

TOLD VICTIM HIS NAME WAS DONNY AND HE WAS GOING TO KILL HER. VICTIM TOLD HIM HER BOYFRIEND JUST LEFT AND HE MIGHT COME UP, SUSPECT SAID HE DID NOT WANT TO HEAR ANYTHING ABOUT HER BOYFRIEND AND THAT HE WAS HER BOYFRIEND FOR THE NIGHT. TO "DEEP THROAT IT" DO WHAT HE SAID TO DO OR HE WOULD SHOOT HER. TOLD HER HE WAS GOING TO KEEP THE BRA SO THAT HE COULD FANTASIZE WITH IT. SUSPECT TOLD VICTIM TO TELL HIM THAT HE WAS THE BEST THAT SHE EVER HAD AND THAT HE WAS HER MAN. SUSPECT TOLD HER THAT HE WAS MARRIED TO A WHITE FEMALE AND THAT HE HAD FOUND HIS WIFE IN BED WITH ANOTHER MAN. ALSO SAID HIS WIFE HAD PUT HIM IN "STOKIE PRISON." HE SAID HE LIVED IN OLDTOWN. HE SAID HE HAD KILLED THREE MEN AND THAT KILLING HER WOULD MAKE NO DIFFERENCE TO HIM.

HELD GUN TO HEAD OR SIDE AT DIFFERENT TIMES. DURING ONE ASSAULT HE TOLD HER TO TAKE BRA OFF (WHICH HE KEPT). HE WRAPPED IT AROUND HIS WAIST AND PUT IT DOWN HIS PANTS.

VICTIM'S BODY WAS PARTIALLY CLAD IN A BEIGE SHORT SLEEVE SWEATER, THE BRA WAS OPENED FROM THE FRONT EXPOSING THE BREASTS, THE BEIGE UNDERWEAR HAD THE CROTCH CUT OR TORN AWAY. THE VICTIM'S NAVY BLUE SLACKS HAD BEEN REMOVED.

WHEN SUSPECT GRABBED VICTIM, SHE WAS TOLD TO KEEP WALKING. TOLD TO GET DOWN ON HER KNEES (TO PERFORM ORAL SEX.) TOLD NOT TO LOOK AT HIM SEVERAL TIMES. HE RETURNED AND ASKED VICTIM WHAT TIME IT WAS.

SUSPECT FOLLOWED VICTIM. SUSPECT GRABBED HER FROM BEHIND HOLDING A KNIFE NEAR HER FACE. AFTER SUSPECT GRABBED HER HE PULLED A BROWN AND TAN SKI MASK OVER HIS FACE AND CONTINUED TO DIRECT HER TO THE NORTH SIDE OF THE BUILDING BY KNIFE POINT. SUSPECT DEMANDED HER POCKETBOOK. SUSPECT RIPPED AND TORE HER COAT AND CLOTHES OFF USING BOTH THE KNIFE AND HIS HANDS. AFTER ATTACK, SUSPECT TIED VICTIM'S HANDS TOGETHER WITH HER BRA, AND HER FEET TOGETHER WITH HER UNDERWEAR AND THEN LEFT.

"HOLD IT, DON'T SCREAM, LET'S GO BACK TO YOUR CAR" STATED SEVERAL TIMES "DON'T LOOK AT ME." TOLD TO GET IN THE PASSENGER SIDE OF VEHICLE SLIDE OVER TO THE DRIVER'S SEAT. SUSPECT GAVE DRIVING DIRECTIONS FOR VICTIM TO FOLLOW AND TOLD NOT TO RUN ANY RED LIGHTS. TOLD VICTIM TO STOP CRYING. ASKED VICTIM IF SHE HAD ANY KIDS. HE ORDERED HER INTO THE BACKSEAT. ORDERED TO TAKE OFF HER BLOUSE, PANTS, BRA, PANTIES, AND STOCKINGS. ORDERED TO LAY DOWN IN BACKSEAT. ORDERED TO LOOSEN HIS BELT, UNZIP HIS PANTS, AND TO TAKE HIS PENIS OUT OF HIS PANTS. ORDERED OUT OF CAR TO PASSENGER SIDE OF VEHICLE WHERE ASSAULT OCCURRED. "STUPID BITCH IT'S NOT LOADED, BUT I GOT A KNIFE HERE THAT WILL KILL YOU DEAD." "I'M GOING TO KILL YOU." "LET'S THROW THE KNIFE."

SUSPECT CAME UP FROM HER LEFT AND STUCK GUN IN HER SIDE AND KIDNAPPED VICTIM AT THE ENTRANCE TO INTEGON. FORCED TO DRIVE TO THE 2500 BLK OF OLD GREENSBORO RD. AFTER THEY ARRIVED AT THE ATTACK LOCATION, SUSPECT REMOVED KEYS FROM IGNITION, TOOK CURRENCY FROM HER POCKETBOOK. SUSPECT PLACED PISTOL ON TOP OF CAR. SUSPECT GOT BEHIND VICTIM AND PLACED KNIFE TO HER THROAT.
